- Alan led the discussion on fundraising and account status- Total amount raised via GFM to date is: \$1879.00. Expenditures for the following, with the following amounts, was disclosed: LibertyCon 2525 table and Ad for \$750; Shopify and dropship charges of \$65; and GFM transfer fees of \$64.45. Treasury currently sits at \$1383.38, including \$30.38 in Shopify account and the \$355 left over in Treasury petty cash
- Banner and stand costs were discussed, best current bid is \$330
- Brochures for LibertyCon are in development with final decisions and orders to be placed no later than 12/31/24 to ensure arrival
- All final material decisions for LibertyCon to be made by 12/31/24

6. **Recap of decisions made**

- Mark G, Airona, and Alan will meet the first week of January to coordinate on further needs to integrate AI bots
- All to focus on fundraising efforts to maintain current needs of the party, grow the party larger, and launch successful future campaigns
- Smaller work team of Mark G, Airona, and Alan will coordinate to brainstorm growing audience and maximizing effectiveness of party influence and reach
- Mark P will continue to work on content for the site, with assistance from Airona, regarding articles
- Ashley will continue to work on marketing and fundraising ideas for the Shopify store

- All orders for materials to hand out at LibertyCon to be placed no later than the end of December
- Andrew to follow up with The Objective Standard regarding further educational materials for those most interested at LibertyCon
